### ANNUAL DUES

AAR Bylaws  
Article III

#### Section 1. Amount, Computation & Responsibility

B.(2).a. Membership dues shall be pro-rated for any licensee included on a certification form submitted to the association who during the same calendar year applies for REALTOR® or REALTOR-ASSOCIATE® membership in the association. However, membership dues shall not be prorated if the licensee held REALTOR® or REALTOR-ASSOCIATE® membership during the preceding calendar year. **NOTE: If a member paid dues in the previous year they must pay full dues and a Processing Fee of \$100 for dues paid after the March deadline.**

#### Section 3. B. Accountability

On a monthly basis, the Member Board/Association shall report to the State Association the names and addresses of REALTOR, REALTOR-ASSOCIATES®, Institute Affiliates Members and Affiliate Member dropped or enrolled during the preceding month.

Section 7: Financial Policies & Procedures

#### Section 7.1 Dues

##### (B) Membership Processing Fee

1. There is levied on each NEW REALTOR® member of the Association a one-time New Membership Processing Fee of \$300.
2. There shall be added to the total dues owed by the Member Board/Association or other Members, a \$100 Processing Fee where such delinquency extends beyond 75 days of January 1.

##### (C) Timely Remittance

Each member Board is expected to remit dues and new member cards on a timely basis by **transmitting a statement at least monthly** showing what, if any, activity has occurred in the preceding period.

### AFFILIATE DUES POLICY

**Affiliates do not pay NAR dues or New Member/Late PROCESSING FEES**

#### Section 7.1.(A) Regular Dues Amounts

3. Affiliates: Affiliate firms may choose to join either the State Association, Local Association or both. Each affiliate firm (at a primary mailing address) who chooses to join both the State Association and Local Association will pay State dues of \$206 annum and local dues annually through their primary Local Association. Affiliates who choose to join the State Association only will pay state dues directly to AAR. Affiliates who choose to join the Local Association only will pay local dues directly to the Local Association.
